16/13/3	The Board noted that this year we did not send AGM papers by post, but instead electronically. This did not affect attendance numbers and we will do this again next year.	
16/13/4	The Board reviewed the Trustee Skills Audit and reminded those who had not submitted their audits to do so as soon as possible. The Board agreed that there were no specific gaps in skills and experience to be filled but noted that the gender breakdown of the Board did not reflect that of the membership and that this was a matter for further consideration.

	A: Honorary and Life Membership	
	Amend 2.14 and 2.3.2 as follows, deleted the parts struck through and adding the parts highlighted:	
	2.1.4 Honorary Member	
	The Board may elect Honorary Members in recognition of some significant service performed by a person (whether a current BHA member or not) to or on behalf of the BHA in furtherance of its Aims. Honorary Members will have all the rights, privileges and obligations of individual Life Members (other than the requirement to pay any form of subscription) and the right to stand for any elected position on the Board. Honorary Membership is for life but may be revoked by the Board. Unless resolved otherwise by the Board. Honorary Membership shall be offered automatically to members of the All Party Parliamentary Humanist Group, Humanist Philosophers Group, and	

Distinguished Supporters (and members of any successors to these groups) for the duration of their time as members of these groups, unless they are already members under another class of membership. Unless resolved otherwise by the Board, Honorary Membership shall be offered automatically to departing senior staff-for-life.

2.3.2 Life Member

The Board shall specify from time to time the amount of the single payment which shall serve to qualify the applicant to become a Life Member. Once the single payment has been accepted the person will be entered in the membership lists of the BHA as a Life Member. All the benefits of membership will be maintained until:

- i. The Life Member retires as in 2.2.3.c above or;
- ii. The death of the Life Member.

Life Membership shall be offered automatically without payment of a subscription to members of the All Party Parliamentary Humanist Group, Humanist Philosophers Group, and Distinguished Supporters (and members of any successors to these groups) unless they are already members under another class of membership.

This is to clear up the ambiguity that currently exists between Honorary Membership and the Life Membership that is offered to Distinguished Supporters and others.

B: Marriages

Add a section 12 to the Byelaws as follows:

Section 12: Humanist Marriages

The Board shall agree usages for humanist marriages to be performed by accredited celebrants.

This is so that we have a mechanism ready by which we can create the necessary guidelines which the conducting of legal marriages will require.

C: The AHS

Insert the existing constitution of the AHS (the National Federation of Atheist, Humanist and Secular Student Societies) as a new section 13 of the Byelaws, with consequent renumbering of its clauses. This is to avoid having a separate document as currently, and will mean that all the rules governing every part of the BHA are in a single document.
