Why should people vote for you?

I'd like to continue bringing my skills and deep experience of UK Humanism to our strong, diverse Board.

What skills and/or experience do you bring to the governance role?

Humanism is a big part of my life: as well as being a Trustee, I'm Humanists UK's Dialogue Officer, Chair of a successful local group, and a school speaker. I've led a major campaign against discriminatory admissions at a new state-funded Catholic school, and helped establish the Fair Admissions Campaign. Being able to draw on a business management background has been invaluable in these activities.

In my Dialogue role I work with humanists and others to advance our vision of a cooperative, secular society, and to promote understanding of Humanism (speaking at the British Islam Conference for example). I have engaged with humanist groups in almost all English and Welsh regions, and plan work with Humanist Students at several universities.

As an experienced Trustee, both on Humanists UK's board and on others, I've seen how well our existing board works: a diverse team of women and men, each making a unique contribution. As well as knowledge and experience of the governance role, I'm capable of taking both a strategic overview, and of getting stuck into the detail when necessary. I'm also willing to put in the effort: during my period as a Board member, I have prepared for/attended, every meeting.

What is your vision for Humanists UK?

Given current evidence, in 20 years there will still be a significant minority of Brits with a range of faith identities, and diversity within them, but a clear majority with no religious identity, including around half with a broadly humanist worldview. Against that backdrop:

- Most of those with a humanist worldview will recognise 'humanist' as a description for it, even if they don't use the label personally, and recognise Humanists UK as the national organisation representing that view. We'll be bigger, and more diverse.
- Some of the need for campaigning may have diminished as Secularism is accepted as the
  best way to run things in this environment, and existing campaigns succeed. But it will not go
  away, and we will continue to be ready for new campaigning challenges.
- Humanists UK will be recognised as an important player in helping this plural, secular society
  work successfully. We will continue to set the standards for non-religious ceremonies,
  pastoral support, and education about Humanism. But we will also be key promoters of
  humanist values kindness, curiosity, empathy, critical thinking and rationality helping
  humanists enrich their own lives, and applying these values in constructive engagement with
  others who share them, and those who disagree.

Why should people vote for you?

I am a dedicated and enthusiastic trustee who is keen for us to fulfil our great potential.

What skills and/or experience do you bring to the governance role?

I have worked within the criminal justice system for the past 14 years in courts, prisons and probation offices. This involves working alongside other agencies with differing perspectives and brings me into contact with people from all walks of life. This work has honed my skills in analysis, diplomacy and communication and I can offer an insight into a world that many do not see. My expertise in safeguarding has been particularly useful during board discussions. I have been told by other trustees that I often think about things in a different way, bringing a fresh perspective during our decision-making processes.

In 2011 whilst working at HMP Winchester I identified the need for non-religious pastoral support for non-religious prisoners and staff. Despite much opposition I initiated this provision and since that time have continued to be heavily involved in expanding our work in pastoral care. I train new pastoral support volunteers for both prisons and hospitals, have spoken in the House of Commons on the subject, and am currently the vice-chair of the Non-Religious Pastoral Support Network. This experience has enabled me to provide the board with knowledge of this area and has developed my ability to think strategically.

What is your vision for Humanists UK?

I believe Humanists UK has a key role to play within our society. We need to be involved in protecting the rights we currently have whilst legislation is reviewed in the wake of Brexit. We should also use this as an opportunity to further improve the rights of the non-religious and improve equality for all. It is vital that we continue to work with humanist organisations in other countries to support efforts where the non-religious are at a disadvantage or in danger. I believe Humanists UK can make a real difference to the lives of many through our community services work as well as our robust campaigning.

Whenever I meet other Humanist UK members I am struck by the strength and warmth they bring and believe this is what gives our organisation such potential to make the most of new opportunities. **Minutes of the AGM of 9 July 2016:** On the proposal of the Board, the minutes were approved *nem con*.

Matters arising from the minutes: There were no matters arising.

Chair's address: Tamar Ghosh reported on the past year's activities highlighting Humanists UK's many successes and hard work ahead. She paid special recognition to Vice Chair Patricia Rogers' immense contribution and announced that she would now be standing down as Vice Chair. Tamar also thanked Andrew Copson, John Adams (Treasurer), and David Pollock (Trustee) for helping her to learn her new role in the past year as well as the staff at Humanists UK for their enormous achievements. Special thanks was given to Director of Operations Catriona McLellan.

Tamar noted that the Board are investing in strategic initiatives by using some of the reserves to extend the reach of Humanists UK. Tamar highlighted as one strategic milestone on the evolving image that would give us the flexibility to reach out to new audiences and to invest in new activities.

A number of questions were asked by members.

**Election to the Board of Trustees: The Company Secretary announced the results of the elections to** the Board of Trustees. The following candidates were elected (in order of election):

Thanks were expressed by all those present to all candidates who stood, whether successful or not and special thanks to Jeremy Rodell for his considerable service and immense contribution on the Board in previous years. Thanks were expressed by the Chair and all those present to Trisha Rogers who left the Board this year.

Annual Report and Accounts for the year ending 31 December 2016: John Adams (Treasurer) presented key figures from the annual accounts. The Treasurer noted that 2016 was a very successful year in financial terms that allowed the organisation to take on three additional full-time staff. The Treasurer reported a decrease in legacies but explained that legacies cannot be planned for and are therefore treated as windfall. Membership subscription income is on the rise and ceremonies income has also increased. There is large increase in expenditure in Pastoral Support and Education and Promotion. The report and accounts for 2016 were accepted *nem con*.

**Re-appointment of Auditor:** Knox Cropper were reappointed as auditor *nem con*. A review of the auditors will take place in 2018.

The number of trustees shall be not less than four and not more than [fifteen] **seventeen**, of whom up to twelve shall be elected by members of the Charity.

To amend 27.1 of the Articles of Association as follows (additions in bold, removals in square brackets):

The trustees may appoint up to [three] **five** members to be trustees in order to provide expertise to the Charity or to make the Board more representative of the membership.
