#### INTRODUCTION

#### FROM ANDREW COPSON CHIEF EXECUTIVE

It's been wonderful to see just how much our movement has achieved in these past 12 months. The pandemic has impacted virtually every area of our work, but in our 125th year, our organisation has proven robust in the face of real challenges. And that is because of members like you, who make an ongoing commitment to humanism, and who have rallied to support us in times of need. Thank you.

You'll see in this report that some of our usual headings have changed. This reflects our new five-year strategy, recently agreed by the Board of Trustees, which we'll be briefing members on at our AGM and in the weeks to come. It reflects the outcome of a detailed process of mapping all the various outputs of our organisation, large and small – from ceremonies, to helping people lead fulfilling lives, to communications that inspire people to learn about humanism, to campaigns that change our society for the better – plus a deep analysis of our strengths, weaknesses, and the external political and social environment.



As well as refining some areas of work, it will see us embark on wholly new and different programmes of activity intended to make humanism more relevant, and accessible to more people, than ever before. More than just a retool, our new strategy amounts to an exciting roadmap for advancing humanism over the next five years. The world is changing, and as always, we are constantly evolving to meet the challenge.

And yet many things remain constant. *Humanist Heritage* launched to celebrate our 125th anniversary and reveals in stunning detail the stories of the men, women, organisations, and daring new ideas that have percolated through our history. Even in the 1890s, we were a forward-thinking movement at the forefront of social change. Your ongoing support makes that as true now as it has ever been.

By advancing the humanist approach to life, we **inspire and support** non-religious people to be **happy, confident, and ethical**, and work with them **for a better society**.

We're a national charity working on behalf of non-religious people, and we've been at the forefront of progressive social change in this country for 125 years. Today, we're powered by over 100,000 members and supporters. The ingenuity, enthusiasm, and generosity of every single person in our movement is absolutely vital to what we do. It's what allows our important work to grow, expand, and flourish – as this report details!

Our policies are formed with the support of more than 180 of the world's most prominent thinkers and experts, including scientists, philosophers, writers, academics, and public figures, and we work to advance these policies with the help of over 100 parliamentarians who are members of the All-Party Parliamentary Humanist Group (APPHG).

#### **PUBLIC UNDERSTANDING**

Our education work continued throughout the lock-downs, with our trained and accredited school speakers engaging with 12,500 pupils remotely this past year. Understandably, demand for our online education resource *Understanding Humanism* increased – with 56,000 users accessing the *Understanding Humanism* website, and a significant shift towards viewing our video resources too!

We've been overwhelmed by the success of our *Little Book of Humanism* since its publication in August 2020. In its first weeks it sold out across all major booksellers, topped Amazon charts, required five additional print runs, and became a *Sunday Times* bestseller. It's received national news and radio coverage, and to this day, has sold over 35,000 copies.

To celebrate our 125th anniversary, we unveiled our brand new website in April 2021, *Humanist Heritage*. The website charts the rich history of the UK's humanist movement and uniquely catalogues hundreds of humanist people, ideas, and innovations.

Our five-star rated podcast, What I Believe, also went from strength to strength and wrapped its third season in June. We've hosted 30 high-profile humanists on the show, seeing 130,000 downloads in the last 12 months, with listeners spanning 100 countries. Fascinatingly, many are tuning in from countries where humanists are openly persecuted, including Saudi Arabia, Pakistan, and Nigeria.


#### **HUMANIST HERITAGE** We've put humanism on the map like never before with our new *Humanist* Heritage website. The resource - the first of its kind - charts the rich and storied history of humanism in the UK. It highlights hundreds of under-recognised humanist campaigners, and reveals the often-overlooked humanist motivations of our national heroes including codebreaker Alan Turing, DNA pioneer Rosalind Franklin, and NHS founder Nye Bevan. Humanist Heritage also introduces a diverse range of biographies of well-known humanists like Albert Einstein. Charles Darwin, and Virginia Woolf, and also of campaigners whose legacies have remained in obscurity despite their profound influence today. They include May Seaton-Tiedeman, who helped legalise divorce because of cruelty or desertion; Elizabeth Swann, our first chair, who helped bring about modern midwifery; Robert Wedderburn, a Scottish-Jamaican humanist in London who galvanised the movement against slavery, and Gustav Spiller, who organised the First Universal Races Congress to challenge racism in 1911. Humanist Heritage unearths stories about humanists like Sophie Bryant [pictured, left] – the Anglo-Irish suffragist and teacher who cofounded the London School of Philosophy, and W.E.B. Du Bois [pictured, right] - the American intellectual who attended the First Universal Races Congress, organised by the Union of Ethical Societies - todav's Humanists UK. #### **EVENTS**

Against all odds, our lectures and events have been extremely successful despite the pandemic. We've reached 25,000 people this past year using our new online format. And, unbound by geographic location, we've been able to reach more people who would have otherwise missed out. This has resulted in some of our most successful lectures ever! We were joined by around 3,000 for our Darwin Day lecture and 2000 for our Rosalind Franklin Lecture, given by Dr Oliver Scott Curry and Professor Sarah Gilbert respectively.

We've also launched a new In Conversation With series in which our Chief Executive hosts unscripted discussions with some of today's top thinkers and entertainers. In addition, fascinating one-off events on global secularism, the Census, climate change, and Humanist Heritage have all added up to make for a very busy and varied events schedule. At the time of publication, we've had more than 20 major events!





Dr Oliver Scott Curry, Research Director at Kindlab, presented his lecture entitled: 'Morality explained: The new science of right and wrong'. It explored the scientific evidence for the origins of moral behaviour not only in humans, but across the animal world.

Professor Sarah Gilbert, Oxford Project Leader for the Oxford/AstraZeneca vaccine, presented her lecture titled: 'Racing against the virus'. Sarah's lecture gave a brief history of the science of vaccination before recounting the astonishing progress of the last year.

#### **SERVING THE COMMUNITY**

Our network of humanists working on the ground now includes 534 humanist celebrants, 224 active school speakers, 137 representatives on council bodies which set RE syllabuses, 238 pastoral carers in hospitals and prisons, and 32 specialists providing dedicated peer support to so-called 'apostates', right across England, Wales, Northern Ireland, the Isle of Man, and the Channel Islands.

## Faith to Faithless

#### **OUR APOSTATE SUPPORT PROGRAMME**

Despite the pandemic, our work supporting and bringing together people who have left high-control religions and cults – so called 'apostates' – has continued well into 2021. We're in the process of hiring a new full-time Apostate Support Service Manager, we've planned for the creation and roll-out of a dedicated Faith to Faithless helpline, and will be holding the first-ever Apostasy Conference in August.

All of our work is backed by extensive in-house research into issues surrounding apostasy. This, as well our apostate focus groups and consultations, forms the strong basis used in our public policy work – including our ongoing work assisting apostates with their asylum applications and work with parliamentarians and MPs.

Our on-the-ground apostasy and safeguarding awareness training also continued into 2021. Upcoming sessions will inform new front-line service professionals on the issues many apostates face including: emotional and physical abuse, shunning, isolation, 'honour' based violence, homelessness, and disownment. We are proud to report that feedback on this training is consistently highly rated at 4.7/5.

#### A RECORD OF ACHIEVEMENT

We've supported over a 1000 apostates since 2017 through our one-to-one peer support, group peer support, events, and socials.

Since 2018, we've responded to over 700 apostates who've reached out to us directly online, including 109 apostates in 2021.

We've trained 293 professionals on the issues apostates face from across 45 organisations – including social services, the NHS, the police, NGOs, and crisis lines.

Our asylum support service has helped over 30 apostates gain asylum.

We've helped develop guidelines for the Home Office in dealing with non-religious asylum claims as part of reforms we instigated on the issue of apostasy.

Since 2018, we have organised 103 apostate socials, peer support meetings, discussions, and museum and gallery tours.

We now have more registered volunteers than ever before to support apostates.

#### PUBLIC AFFAIRS AND POLICY

#### SUPPORTING NON-RELIGIOUS PEOPLE THROUGH THE PANDEMIC

We've supported the non-religious during the pandemic by continuing our educational resources and pastoral support remotely, by successfully campaigning for the equal treatment of humanist weddings under coronavirus rules, and by working with parliamentarians to address the persecution of humanists abroad. We've also encouraged our 100,000 members and supporters to volunteer with the NHS, mutual aid groups, and vaccination centres, and to donate to charities and food banks.

This year, our patron Dr Henry Marsh called on parliamentarians for an urgent inquiry into assisted dying laws in England and Wales. Over 50 MPs and peers supported Marsh's call in a joint letter to the Justice Secretary.

led by members of the All-Party Parliamentary Humanist Group. We organised the high-profile intervention alongside My Death, My Decision, and secured extensive media coverage, putting Henry's story in front of millions. It was a main news story on BBC One, and was also featured in *The Times, Daily Mail, Guardian, Evening Standard,* as well as on the BBC Radio 4 *Sunday* programme, BBC Radio 2, LBC, and *Good Morning Britain*.

The intervention received cross-party support from parliamentarians, including some who previously voted against changing the law. It's been six years since Parliament last examined legislation on assisted dying, and 16 years since it formally scrutinised the evidence. We also rallied support from our members to write to their MP to back an inquiry. It's important for public policy to align with medical and public

opinion on this issue – which has thoroughly shifted in favour of a compassionate law with transparent and rigorous safeguards.

In June, we learned that two leading assisted

dying campaigners had sadly died. Our members Noel Conway and Paul Lamb spent their final years valiantly fighting for the right to die. We intend to honour their memories by continuing their fight.

#### HUGE REACH FOR OUR CENSUS 2021 CAMPAIGN

It was time for our Census Campaign in March. Our message to the public was simple: If you're not religious, say so! Tick 'No religion' in the 2021 Census. Thanks to our ground-breaking digital strategy we were able to reach 12 million people, became a leading voice in conversations about the Census, and reached more people than protest campaigns surrounding questions on sex, national identity, and the environment.

We also received extensive media coverage across the press and ran print ads that expressed our message to

ads that expressed our message to millions. Members were also a big part of our efforts, with many writing to local newspapers, putting up posters in their community, and supporting our online activity in droves. Thank you! Although we won't know the results of the Census until at least 2022, we can take pride in the unprecedented digital reach of our campaign.

#### EXPOSING MISOGYNY IN FAITH SCHOOLS

We first exposed the misogynistic Catholic sex education resource *A Fertile Heart* in January. The resource teaches that 'man was created to be the initiator in sexual relationships' and that women are passive 'receiver-responders'.

It also teaches that the contraceptive pill is wrong and prevents women understanding 'fertility and femininity', likens same-sex marriage to polygamy, and teaches that same-sex couples must not marry and should abstain from sex.

We were swift to call out the resource for what it really is: pseudo-scientific religious propaganda. In June, Ofsted carried out one snap inspection on a school in Hereford using the resource.

To pass inspection the school was forced to change the language used in it. School leaders said they were only using the materials because they were 'asked' to by the Archdiocese of Cardiff – which has defended it on the grounds that it 'reflects Catholic teaching'.

A Fertile Heart demonstrates exactly why it's so worrying that the law allows religious organisations to provide Relationships and Sex Education. Young people deserve factual information that will keep them healthy, happy, and safe – not religious perspectives that deny them knowledge of consent, contraception, equality, and (simply put) the truth.



#### SEX ED COMPULSORY IN ENGLAND AND WALES

After 50 years of our campaigning. Relationships and Sex Education became compulsory in England. The new regulations came into force in England last September, and will come in to force in Wales in September 2022. Primaries in England now teach Relationships Education and secondaries teach Relationships and Sex Education. We celebrated the news, but pointed out that UK Government guidance is far from perfect. Faith schools are still able to provide RSE from a faith perspective. This means many schools will avoid teaching it, while others will provide religious views in place of facts. Consent, mental health, what constitutes a healthy relationship - this is all vital information to keep young people healthy, happy, and safe.

#### BLASPHEMY LAW REPEALS: SCOTLAND, NORTHERN IRELAND

We celebrated a historic moment in April after Scotland repealed its blasphemy law. The Scottish Government first announced it would abolish the common law offence of 'blasphemy' last year as part of the Hate Crime and Public Order (Scotland) Bill. We assisted our sister charity Humanist Society Scotland in securing amendments to the draft Bill, adding robust protections for freedom of speech to the final Act of the Scottish Parliament, which received

royal assent in April.

The new law leaves Northern Ireland as the only part of the UK with a blasphemy law on the books. But our campaign for repeal in Northern Ireland continues to go from strength to strength, and in March the Justice and Finance Ministers, Naomi Long and Conor Murphy, confirmed their support for our campaign. As they are the relevant ministers responsible for any change, this represents very significant progress. Since we co-founded the End Blasphemy Laws campaign in 2015, they have been abolished in Denmark, Ireland, Norway, Iceland, Malta, France, New Zealand, Canada, and Greece. Scotland joining this list will only strengthen our campaign in Northern Ireland where every major party except the DUP backs our call for repeal.

#### **OUR HUMAN RIGHTS COALITION IS NOW OVER 200 ORGS STRONG**

As of June, more than 200 organisations, including charities, trade unions, human rights bodies, and religion or belief groups, have joined our coalition to defend the Human Rights Act and right to judicial review. We formed the large coalition in response to emerging determination from the Government to weaken these constitutional safeguards, against infringements of rights and arbitrary decision-making. We are proud to have established this vital network of organisations committed to protecting our most basic rights.

#### HIGH COURT RULES ON HUMANIST MARRIAGE CASE

In July 2020, we celebrated a milestone success after the High Court ruled that the failure to extend legal recognition to humanist

marriages in England and Wales is 'discrimination'. Six humanist couples took the claim to the Court. The case received widespread coverage, including BBC *Breakfast*, Radio 4's news bulletins, several regional BBC and ITV news programmes, BBC News Online, and all the UK-wide, Northern Ireland, and Republic of Ireland papers. Mrs Justice Eady DBE ruled that the Secretary of State for Justice 'cannot... simply sit on his hands' and do nothing. However, she said given that the Government is considering the matter in the form of a review into marriage law by the Law Commission, the Government's refusal to act immediately can be justified 'at this time'.

This represents significant progress. It moves the question of legal recognition from one of 'if' to one of 'when'. However, it's disappointing that the judge decided to give the Government even more time to resolve an issue that it has been reviewing for eight years. The couples are now exploring an appeal of the judgment on this point.

We will support them whatever they decide to do, and are telling the Government and Law Commission that this judgment means they should speed up the review.

#### HUMANISM ON EQUAL FOOTING TO RELIGION IN WELSH CHOOLS

In April we celebrated the final passage of the new Curriculum Act that puts humanism on an equal footing with religion in Welsh schools. The Curriculum and Assessment (Wales) Act received royal assent that month. The new curriculum is expected in September 2022 and the law will also change the name of Religious Education to Religion, Values, and Ethics (RVE). It also clarifies that humanists may sit on SACREs (renamed SACs) and ASCs, the bodies that oversee and develop local syllabuses.

This took years of campaigning, and after powerful religious groups threatened to reverse years of progress, eager to retain 'confessional RE', we rallied our members to write to their MSs on this issue. Now Wales is set to become a world leader in inclusive education by protecting children's rights to broad, balanced, and inclusive RVE lessons.

#### BIG WIN FOR HUMANIST INCLUSION IN RE COMMITTEES

In April, Southampton Council backed down on its decision to block a humanist, Mary Walbank, from joining the local RE committee after we threatened to take legal action. The Council's original decision followed consultation with religious members of the committee. One Anglican representative referred to humanist inclusion as a 'Trotskyist move'. This behaviour demonstrates a lack of understanding of what humanism is and ignores the fact that over 40 RE committees (known as SACREs) in England already have humanists as members. The High Court ruled in 2015 that humanism should be taught as part of RE. Southampton Council flew in the face of that ruling, and human rights law.

#### CALLING FOR FREEDOM OF RELIGION OR BELIEF IN CHINA

Since 2019, we've condemned the coercive treatment of Uighurs in the Xinjiang region of China in the strongest possible terms. Prior to MPs voting to declare the Uighur persecution as genocide in April, we called for action to be taken at the UN Human Rights Council, and defended our statement against objections from China's delegates. We also put our weight behind the so-called anti-genocide amendment in January – which strengthened the UK's requirement to oppose genocide.

#### ONE YEAR IN PRISON: NIGERIAN HUMANIST MUBARAK BALA

It's now been over one year since the arrest of Mubarak Bala, President of the Nigerian Humanist Association. He was accused of being 'provocative and annoying to Muslims' on Facebook, but has been held since April 2020 without charge.

Since his arrest, we've coordinated media coverage of his situation with Humanists International, held high-level meetings with Foreign, Commonwealth, and Development Office ministers and officials, staged a protest outside the Nigerian High Commission in London, raised his case at the UN Human Rights Council, in the UK Parliament, and with members of the All-Party Parliamentary Humanist Group. We joined over 90 other human rights organisations in calling for his immediate release.

#### GROWING THE PROFILE OF HUMANISM: NEW PATRONS OF HUMANISTS UK

Our ongoing work to raise the profile of humanism is reflected in the number of well-known faces publicly identifying themselves as humanists. As of 2021, Humanists UK has over 180 high-profile patrons, including Nobel laureates, politicians, scientists, broadcasters, authors, entertainers, athletes, artists, actors, and musicians.

New patrons of Humanists UK appointed in the last year include the playwright Wole Soyinka; the actors Ralf Little, Kristian Nairn, and Isaac Hempstead Wright; astrophysicist and poker champion Liv Boeree; the award-winning journalist Felicity Hannah; psychologist and former NBA player John Amaechi OBE; feminist writer Zoe Fairbairns; novelist Stephanie Merritt; abortion and assisted dying campaigner Wendy Savage; and creator of the WordPress website-building tool Mike Little. We're delighted to have each and every one of them on board, supporting our work.

#### ALL MAJOR POLITICAL PARTIES GIVE THANKS TO HUMANISTS

Ahead of our 125th anniversary celebrations in April, we received video and written messages of support from leading politicians, each of whom set out the historic and current contributions of humanists to the country. We received thanks for our work from the First Minister of Scotland and SNP leader Nicola Sturgeon MSP, the UK Leader of the Opposition, Sir Keir Starmer MP; the leader of the Liberal Democrats, Sir Ed Davey MP; the coleader of the Green Party of England and Wales, Sian Berry AM; and the Government's minister responsible for relations with humanists, Lord Greenhalgh. Their congratulations comes as a sign of the growing political importance of humanists and recognition of our work and the positive impact of humanism on society.



#### **100 YEARS OF WELSH SECULARISM**

In December, Wales Humanists held a virtual event in Senedd Cymru, the Welsh Parliament, to celebrate 100 years on from the enactment of the Welsh Church Act, which disestablished the Church of England in Wales.



At the event, we were joined by Wales Humanists patrons Dr Iolo ap Gwynn and Julie Morgan MS as we launched a new bilingual report on 100 Years of Disestablishment [pictured] which examined the far-reaching impact of disestablishment and recommended aspects of modern Wales' exemplary and by and large pluralistic and secular political culture. The report cited several ways in which Wales could work to fulfil and build on the proud legacy of civic pluralism since disestablishment, by ending discriminatory faith schools, ending compulsory collective worship in schools, giving legal recognition to humanist marriages, holding inclusive public ceremonies, and reforming NHS chaplaincy guidelines to require humanist pastoral support in all hospitals.

58% of people in Wales today say they have no religion, making it the least religious part of the UK. Wales Humanists is the largest section of Humanists UK.


