ABOUT HUMANISTS UK

We are an active member of many organisations working on education and children's rights. These include the Children's Rights Alliance for England (CRAE), the PSHE Association, the Sex Education Forum, and the Religious Education Council for England and Wales (REC). We provide materials, resources, and advice to a range of education stakeholders including parents, governors, students, teachers, and academics.

We lead the national campaign for action on unregistered religious schools and work closely with former pupils of such settings, as well as current members of closed religious communities, to highlight their experiences and provide evidence to the authorities. Our work in this area includes working directly with community whistleblowers and our apostate support programme Faith to Faithless.¹ It has generated substantial and significant media coverage on the issue of illegal schools, including features on *Newsnight*² and *BBC News at Six and Ten*.³ This coverage prompted the creation of Ofsted's unregistered schools team. We were the first external group to meet with that team, and the first to introduce them to pupils who had attended such schools. It also prompted Hackney Council's own review of the issue in the local area. Our work has led us to conclude that the law surrounding both home education and illegal schools needs to be entirely overhauled to ensure that the latter can be shut down once and for all.

Please explain why you think additional children should/shouldn't be included in the statutory duty relating to CME:

Since children who attend unregistered and illegal schools are generally not receiving a 'suitable education', they arguably already fall within the scope of the statutory duty relating to CME. However, current legal loopholes (including the lack of a statutory definition of full-time education in the 1996 Act⁴) enable many unregistered religious schools to operate with impunity on the basis that they purportedly provide only part-time religious instruction. We therefore believe that pupils attending unregistered and illegal settings, including those who are purported to do so only on a part-time basis must be explicitly included in the duty.

The lack of adequate regulation pertaining to illegal schools and the absence of a home education register represent huge barriers to the identification of CME, with the proprietors of unregistered religious settings exploiting legal loopholes to deny children a suitable education and LAs and Ofsted powerless to do anything to stop them.

greater powers to inspect illegal and unregistered settings. These provisions in the recently scrapped Schools Bill not only had wide cross-party support when debated in the Lords, but were also endorsed by the Independent Inquiry into Child Sexual Abuse,⁵ the Bloom Review,⁶ and the Education Select Committee.⁷ Without such changes, it will be impossible for LAs to identify or support all CME.

This call for evidence focuses on what can be done by schools, LAs, and other agencies to identify CME. However, it ignores the fact that, without legislation requiring the registration of all children educated outside of school and which also prevents the operation of illegal schools, authorities will be forced to address the problem with one hand tied behind their back. The DfE is well aware that pupils at illegal schools are denied an adequate curriculum and are often subject to serious abuse in unsafe conditions. This is a national scandal that must be addressed at the earliest opportunity.
