Declarations of Interest: The Chair reminded those present that members speaking should declare any potential conflict of interest in relation to any item.

Minutes of the AGM of Saturday 23 July 2012: On the proposal of the Board, the minutes were approved *nem con*.

Matters arising from the previous minutes: There were no matters arising.

Chair's address: The chair reported on the past year's activities, highlighting the BHA's many successes and the hard work ahead. Annual Report and Accounts for the year ending 31 December 2012: John Woolhouse (Treasurer) presented key figures from the annual accounts. He drew attention to the revised reserves policy, which introduced greater financial flexibility for the BHA; and the need for fundraising was heavily underlined. The Report and Accounts for 2012 were accepted *nem con*.

Re-appointment of Auditor: The firm of Knox Cropper was reappointed as auditor *nem con*.

Remuneration of Auditor: The trustees were authorized to determine the remuneration of the auditor *nem con*.

Emergency Motions: No motions had been received.
