

# HOW TO OPT OUT FROM RE AND COLLECTIVE WORSHIP AS A TEACHER

Briefing from Northern Ireland Humanists, January 2026



## ABOUT NORTHERN IRELAND HUMANISTS

## How to opt-out from delivering RE and collective worship

### As a teacher in a controlled school (excluding controlled integrated schools)

If you **teach in a controlled school**, excluding controlled integrated schools, in Northern Ireland, [Article 22 of the Education and Libraries \(Northern Ireland\) Order 1986](#) provides a route to be wholly or partly excused from:

- conducting or attending collective worship, and/or
- teaching Religious Education (RE)

### To do this, you submit

1. a cover letter requesting withdrawal to the Board of Governors, and
2. a statutory declaration stating the request is made solely on grounds of conscience.

### Witnessed by a lay magistrate

In Northern Ireland, you can have the statutory declaration witnessed by a lay magistrate. [NI Direct](#) states that lay magistrates will not ask you to pay anything for witnessing (in the context of official witnessing requirements).

- **How to book in with a lay magistrate:** NI Direct provides a [contact route](#) via the Northern Ireland Courts and Tribunals Service that can help you find a lay magistrate in your area.

### Witnessed by a solicitor

If you prefer a quick in-office appointment, a solicitor can witness the declaration for a small fixed fee. [Phoenix Law](#) will charge between £30–£50 to sign a witness declaration, other solicitors are available.



## What teachers need to do

1. Fill in the [cover letter](#) and [statutory declaration form](#) (these are also in this pack to copy and paste)
2. Book and attend a lay magistrate appointment (free) and have them witness the signing of the declaration.
3. Send both documents to the principal (asking them to table it with the Board), directly to the Board clerk/chair, or both.
4. Ask for written confirmation and the effective date of withdrawal to take place.
5. Move to practical arrangements: who is taking the RE cover and what happens during assemblies. In some cases, such as if there are staff capacity constraints, schools can get funding to cover the cost of employing an extra teacher to cover RE and collective worship.

## As a teacher in other schools

There is no equivalent statutory right for teachers in **maintained** or **integrated** schools. Any withdrawal from teaching RE / leading worship is usually a **contract and HR matter** (job description, directed duties, internal accommodation), rather than a built-in statutory opt-out like Article 22.

A teacher could still ask to be reassigned away from those duties, but it's not an automatic statutory entitlement in those sectors.
